### **CULTURAL INSIGHT**

#### 1. Public housing

In Hong Kong, nearly half of the population lives in public housing.

#### 2. Partitioned flats

Partitioned flats are a common form of rental housing in Hong Kong. These flats are shown on building plans as being divided into two or more individual spaces.

#### 3. Home Ownership Scheme flat

This is a subsidized-sale public housing program managed by the Hong Kong Housing Authority. Under the scheme, the government sells apartment flats to eligible tenants and low-income residents at prices below the market level.

#### 4. Private estates

Housing estates are developed by private developers rather than the the Hong Kong Housing

Authority or the Hong Kong Housing Society. They usually have a cluster of high-rise buildings with their own market or shopping mall.

## 5. Luxury apartments

Hong Kong is the most expensive place in the world to rent a high-end, three-bedroom apartment, according to the latest data from ECA International. Rent for an unfurnished three-bedroom apartment in a sought-after area of Hong Kong averaged US\$ 1,550 per month in 2012.
